**RAIL:** Burlington Northern Santa Fe transload service is available along Interstate 215, immediately west of Moreno Valley. The city is approximately 18 miles south of the San Bernardino intermodal yard. Metrolink commuter rail service is available 10 miles west of Moreno Valley and provides access from Riverside to Los Angeles, Orange and San Diego Counties.

TRUCK: 37 carriers have locations in Moreno Valley.

**OVERNIGHT DELIVERY TO:** Los Angeles, San Francisco, San Diego and Phoenix.

AIR: LA/Ontario International Airport (owned and operated by Los Angeles World Airports), 30 mi. west, provides both passenger and air cargo service. Passengers are served by ten airlines. United Parcel Service operates a west coast cargo hub and provides direct service to the Asia/Pacific Rim market. Riverside Municipal Airport has general aviation facilities, a 5,400 ft. runway and a 2,851 ft. runway. Through a joint use agreement with the U.S. Air Force, portions of March Air Reserve Base have developed as a major air cargo facility known as the March Inland Port. The Moreno Valley Industrial Area is immediately adjacent to the March Inland Port, which boasts a 13,300 ft. runway and more than one million square feet of ramp area. The Department of Commerce has designated the March Inland Port as Foreign Trade Zone #244.

**BUS:** Riverside Transit Agency provides local bus service and connections to Riverside, Perris and Hemet. Greyhound provides access from Riverside to all points and in Perris, 10 mi. south.

PORTS: Nearest ports are in Los Angeles-Long Beach, 75 mi. west, and San Diego, 105 mi. south.

# Governmental Facilities - Tax and Insurance Rates

**HIGHWAYS:** Located at the junction of Interstate 215 and 60 (the I-215/15 connects to San Diego and Las Vegas, the 60 connects to Los Angeles and Arizona), Moreno Valley is the gateway to Southern California metro markets. Highway 60 meets the 91 Freeway 7 miles to the west in Riverside, providing connections to Orange County and Long Beach and joins Interstate 10 in Beaumont, 15 miles to the east.

Moreno Valley contains approximately 2,572 acres zoned for industrial development uses. It is home to such companies as Cardinal Glass Co., Masonite, Modular Metal Fabricators, Porvene Doors, ResMed, Serta Mattress, Supreme Truck Bodies; and distribution centers such as Frazee Paint, Minka Lighting, O'Reilly Automotive, Phillips Consumer Electronics, Ross Dress for Less, United Natural Foods and Walgreens. In addition, more than 6 million sq. ft. of industrial space is under development or available, including a 1.8 million square foot distribution center for Skechers USA to open in 2011. These companies and new development projects set the tone for Moreno Valley's continuing industrial growth.

The city's three industrially zoned areas include the Centerpointe Business Park, Moreno Valley Industrial Area and SR 60 Business Park Area. Citywide, industrial/commercial parcels range in size from one acre to 200 acres. Moreno Valley offers abundant industrial sites with excellent access to the Southern California market at very competitive prices. **SEWER:** Eastern Municipal Water Dist., Edgemont Community Services, Western Municipal Water Dist. Capacity of sewer plant: 16 million gal/day. Average flow: 11.6 mg/d. Sewer service charge: Yes. On what basis rated: \$0.711/day/EDU. Type of treatment plant: Tertiary. Any facilities for non-recoverable wastewater: By truck at dump station approx. 15 mi. Sewer back up and treatment capacity (connection) fees are based on estimated daily water use for the specific project, front footage of the project, and actual cost of installing the service(s). Four Master Drainage Plans are in place covering 95% of Moreno Valley. The four plans include: 1) Sunnymead Area Plan (construction underway; funded by Area Drainage Plan fees); 2) Moreno Area Plan (construction underway; funded by Area Drainage Plan fees); 3) The Perris Valley Area Plan (construction underway; funded by Area Drainage Plan fees); and 4) West End Plan which includes the areas of TownGate, Box Springs, and southwest Moreno Valley. Street dedication requirements: Per General Plan. Improvement requirements: In most cases, curbs, gutters, match-up paving, streetlights, sidewalks, street trees and landscaping are required.

The Moreno Valley Electric Utility provides electrical service to new commercial, industrial, and residential development, primarily on the east end of the city.

- Police Department: The city contracts with the Riverside County Sheriff's Department to
  provide all police services including general law, traffic, special investigations, crime prevention
  and school resource. The department has 184 sworn personnel, 53 non-sworn personnel and a
  150-unit vehicle fleet.
- Fire Department: Fire protection services for the city are provided by Riverside County Fire Department through a contract with the California Department of Forestry and Fire Protection. The department has 72 paid firefighters, 6 fire stations, supporting 6 paramedic engine companies and 2 100-foot aerial tiller truck companies. The city has 11 volunteer reserve firefighters and 2 Explorer Posts with 34 cadets. Services include fire suppression, advanced life support medical services, public service, fire-menace stand-by, hazardous materials, fire prevention and related services.

### Characteristics of the Labor Force

**Extent of Unionization:** Unionization has been minimal and is generally restricted to the building trades and retail clerks in major supermarket chains.

Moreno Valley offers an abundant supply of skilled and semi-skilled labor, with some workers commuting to jobs outside the area. **HEALTH:** Kaiser Hospital - Moreno Valley and has a 202 total bed capacity. The 439-bed Riverside County Regional Medical Center is also located in Moreno Valley. There are 199 physicians/surgeons, 71 dentists, 17 optometrists, 15 chiropractors and 3 podiatrists that practice in Moreno Valley.

**EDUCATION:** There are 23 elementary schools, 6 middle schools, 4 high schools, 1 continuation high school, 1 alternative school, 1 K-12 school, 1 community day school, 1 special education school and 1 adult school. Nine private schools are located in Moreno Valley. Opportunities to pursue higher education abound in Moreno Valley. Moreno Valley College currently instructs more than 10,000 students. With 26 additional community colleges and world-renowned universities in the area, including the adjacent University of California, Riverside, the Claremont Colleges, Loma Linda University and California State University-San Bernardino, Moreno Valley provides commercial and industrial growth with the skilled labor required for the 21st century.

**RECREATIONAL/CULTURAL:** "Rated Number One in Riverside County for Family Recreation" by The Press-Enterprise newspaper, the City has three golf courses including the 27-hole Moreno Valley Ranch Golf Club, ranked among the top 75 public golf courses in the U.S. Moreno Valley is also home to the 8,000-acre Lake Perris State Park, which offers boating, fishing and camping facilities. Box Springs Mountain Park provides trails for hiking and horseback riding. Moreno Valley's Parks & Recreation Department maintains 32 parks with more than 358 acres, a 9-hole executive golf course, public tennis courts and numerous programs and services for youth and adults. Moreno Valley's centralized location allows residents to visit nearby mountain resorts, Palm Springs and the beach cities with relative ease.

There are 104 churches, 1 newspaper, 1 library, 12 banks, 2 savings and loans, 1 senior center, 1 bowling center, 2 movie theaters with a total of 24 screens, a radio station and a 1.2 million square foot regional shopping mall.

According to the California Department of Finance, there are 53,772 housing units in Moreno Valley. The housing stock consists of 42,812 single detached units, 1,105 single attached units, 1,768 multiple 2 to 4 units, 7,044 multiple 5 plus units and 1,043 mobile homes.

The median sales price for new and existing homes is \$158,250, as reported by DataQuick for September 2010.

There are 11 hotels/motels, with 931 rooms, in Moreno Valley.

There are 7 mobile home and RV parks in Moreno Valley with 872 mobile home spaces.

Moreno Valley offers a comfortable, affordable lifestyle for those wanting to own their own home and raise a family. Business opportunities are excellent. Commercial and industrial developments are desired and encouraged with several major projects being planned or currently underway. Growing, dominant industries are logistics and healthcare.
