Summary

The RFQ included various consultant services including construction management firms and labor compliance consultants. The RFQ's were submitted for the purpose of developing a pool of pre-qualified consultants to perform project services on an as-needed basis.

**BACKGROUND:**

**Summary (Continued)**

Creating a list of pre-qualified consulting firms is in conformance with Board Policy H-7 and is intended to enable EDA to quickly respond to client needs and accelerate the delivery of several capital projects that are progressing towards the construction phase. In accordance with the policy, the period of qualification for the selected firms will remain in effect for a maximum of three years from the date of Board approval.

In accordance with Board Policy H-7 and Public Contract Code, a selection committee was established to review each firm's qualifications. After reviewing the submitted qualifications, 16 firms were selected for construction management services and 8 firms were selected for labor and compliance consulting services as the most qualified to meet the county's needs. Each firm offers particular strengths that may apply to different types of projects.

The consulting services will be retained on an as-needed basis via the issuance of a contract or purchase order for negotiated services including, but not limited to, agreement on the scope of work, terms, conditions, and compensation. The consultant services fees will not exceed \$100,000 per project.
